# Resource Use Efficiency and Profitability of Sweetpotato (*Ipomea batatas* L.) Production in Etche Local Government Area of Rivers State, Nigeria

#### **Abstract**

This study examined the resource use efficiency and profitability of potato production in Etche Local Government Area of Rivers State, Nigeria. Sweetpotato is one of the crops pivotal to overcoming food insecurity in sub-Saharan African countries including Nigeria. However, despite the numerous benefits of sweetpotato, the production of sweet potato in Nigeria is still below the nation's potential. This research examined the socio-economic characteristics of the potato farmers and factors influencing efficiency and returns to scale/profitability of potato production in Rivers State, Nigeria. Multi-stage sampling technique was adopted by selecting a sample of 200 small-scale potato farmers, primary data was gathered through a structural questionnaire. Descriptive statistics and stochastic frontier analysis were used in realizing our objectives. The results indicated that the average age of farmers in the study area was 42yrs, with house-hold size of 11 persons, mean years of experience was 11 years, size of farm land 1.0 ha. The result showed a mean technical efficiency of 76%. The allocative elasticity index (AEI) was greater or less than one. This indicated inefficient allocation. However, the result also revealed that variables like, level of education, years of experience, gender and size of family could enhance farmer efficiency. The returns to scale/profitability analysis indicated a 91.27% return on investment, however, some constraints were established such as high cost of planting materials, lack of capital, transportation, lack of access to loan, high cost of land and destruction of crops by livestock (herders cattle). It was therefore recommended that more access to capital through government intervention and more awareness will increase investment in sweetpotato production and agricultural development in general.

# 1.0 Introduction

Sweetpotato (*Ipomea batatas* L) belongs to the family *solanaecae*, it is closely related to the Irish potato (*Solannum tuberosum* L.). Sweet potato originated from South America and was later introduced into Europe. By the middle of the eighteenth-century sweetpotato has become widely

cultivated and serves as a major food crop in the whole of Europe as well as other parts of the world including Nigeria. Early cultivation of sweetpotato (*Ipomea batatas* L) and *Solannum tuberosum* L in Nigeria was around Jos in Plateau State and Offa in Kwarra State (Tewe *et al.*, 2003).

Analysis revealed that sweetpotato is a good source of energy, providing about 70 calories of energy per 100gram (Ajakaiye and Akande 2016). It contains about 78% water, 16% carbohydrate, 2.1% protein and some amount of minerals and vitamins; the root tuber of some varieties (orange fleshed) can be chewed raw like carrot; the leaves and tender shoots can be used as vegetable for soup, the leaves are much richer in protein, mineral and vitamin than the roots (Ajakaiye and Akende 2016). Sweetpotato ranks among the five most important food crops in developing countries (Ben et al., 2024; Potato New World Encyclopedia, 2018). Industrial use of sweetpotato flour as a substitute for wheat flour in bread baking has been reported by (Agbo & Ene 2012). Baby foods have also been formulated using sweetpotato. However, some medicinal values of sweetpotato have been revealed, Azuogu & Oloma (2020), reported medicinal value such as the treatment of inflammation, arthritics pain and stomach ulcers, bronchitis and cardiovascula diseases, reduction and regulation of blood pressure etc. In Sub-Saharan African Countries including Nigeria, sweetpotatoes has gained importance in overcoming food insecurity, it is widely accepted, and some local cultivars have been introduced. For example: KENSPORT 3 KENSPORT 4, KAKAMEGA, KABODE and SUNAIMA. The yield per hectare of sweetpotato globally ranges between 20 – 50 tonnes/ha (Adeyonu et al., 2019). Potato production has expanded due to availability of improved technology, expanded irrigation structure and increasing market value (Eiar & Arari 2013).

Despite the numerous benefits of sweetpotato, the production of sweet potato in Nigeria is still below the nation's potential; Nigeria had one of the world's lowest average yields per hectare of 3.1 tonnes. The low yield of sweet potato in Nigeria may be due to quality of planting material (Vines) and high cost of labour (Ben *et al.*, 2024). However, Fawole (2017) traced the low productivity to farmers inefficient use of resources. One major way of increasing productivity is by enabling farmers utilization of resources (Antia-Obong *et al.*, 2021; Oladele *et al.*, 2014). Production can be increased by making some adjustments in the use of inputs or through the adoption of modern and improved technology.

Compared to yam and cassava (other tuber crops) little works have been done on the economics of sweetpotato production in Etche Local Government Area of Rivers State, Nigeria. Therefore, this study was carried out to (a) examine the socio-economic characteristics of sweetpotato farmers in Etche L.G.A of Rivers State (b) determine the technical and allocative efficiency (c) ascertain the profitability of sweetpotato production and identify the constraints against sweetpotato production in Etche L.G.A of Rivers state.

# 2.0 Materials and Methods

# 2.1 Study Area

The study was carried out in Etche Local Government Area of Rivers State, Nigeria. The land mass of the area is about 750km² with a population of over 900,000 people (National census, 2006). According to Nlerum (2006) Etche Local Government lies between longitude 4.47 and latitude 6.70, Situated on the Northeast axis of Rivers state. The local government is within the up-land region of Rivers State with a tropical climate and experiences two major seasons of rainy and dry seasons. It has a verse array of table land which supports various Agricultural activities, and it is often regarded as the food basket of the state. The major occupation of the people is farming. The major crops cultivated include – yam, cassava, maize, plantain, cocoyam, potato, oil palm, with cassava, yam and

plantain taking the lead,. The cassava production gives rise to the popular Etche garri which has high amount of starch. However, the presence of Imo Rivers, Ogochie River and the popular Otamiri River makes fishing activities possible. Etche Local Government share inter-state boundaries with Imo and Abia States, Southeast Nigeria. It also share boundaries with other local government in Rivers State like, Obio/Akpor, Oyigbo, Omuma and Ikwerre Local Government Areas of Rivers State. One of the earliest discovery of crude oil in Nigeria was in Umuechem Etche Rivers State and still produces the high quality Bonny light crude till date.

#### 2.2 Method of Data Collection

Etche local government area has two state constituencies, Etche constituency 1 and Etche State constituency 2. Each of the two state constituencies is made up of three clans. Constituency 1 comprises of Okehi clan, Mba clan, Ozuzu clan with about 20 autonomous towns/communities while constituency 2 comprises of Igbo Ulakwo and Umuselem clans, with about 21 autonomous towns/communities. The population of this study was the entire sweetpotato farmers in the forty one (41) autonomous communities in Etche local government area. Multi-stage sampling technique was adopted. Firstly, two clans each from the two state constituencies were selected. The clan selected for the study was Ozuzu and Mba clans from constituency 1, while Igbo and Umuselem clans were selected from constituency 2, based on their scope of involvement in farming activities from the list of potato farmers in the area which is as follows, 150, 170, 202 and 145 farmers drawn from the four clans respectively, giving a total of (667) sweet potato farmers. Out of which 30% of sweetpotato farmers from each clan were randomly selected giving a sample population of 200 potato farmers for this study. A well-structured questionnaire was administered to generate our primary data.

#### 2.3 Analytical Technique

Descriptive statistics such as frequencies mean and percentages were used in data analysis, also stochastic frontier production function was used to determine resource efficiency, while a five points Likert scale was used to evaluate the constraints militating against potato farmers in the area. Functional form of cobb-douglas production function was adopted as specified by Coelli (1996). Profitability and economic efficiency of sweetpotato production was determined with specific type of budgetary analysis/gross margin analysis and net farm income (NFI).

**Decision Rule:** if  $U_i = O$ , no technical inefficiency, the production lies on the stochastic frontier. If the  $U_i > O$ ; the production lies between the frontier and it is inefficient. Since the dependent variable is a measure of inefficiency, farm specific variables with negative/positive co-efficiency will have a positive/negative effect on efficiency levels.

# 3.0 Results and Discussion

# 3.1 Socio-economic Characteristics of Respondents in the Study Area

Table 3.1 showed that 59% of the farmers were female only 41% were male, this is contrary to the position of Ekunwe (2018) who reported in his earlier study that majority of yam farmers in Tai Local Government Area of Rivers State (a similar local government) were male. The age of potato farmers in the area varies between 25 –60 yrs with a mean age of 42 yrs. However, Shreastha *et al.* (2017), Tayinde (2014) reported a mean age of 51 years. This goes to confirm that potato farmers were at their peak age of productivity. Most of the potato farmers were married as 70.5% of the respondents were married and women. The results revealed an average household size of 11 persons. This supports the use of family member's source of labour, previously reported by Ekunwe et al. (2008). About 49% of the respondents had minimum of post-primary education, while 44% had primary education, which means that most of the farmers had basic education. Ike *et al.* (2008) and Adenyonu (2019) indicated that education is positively related to farmer's level of efficiency. On the years of experience about 45.5% of the respondents had 10 – 14 years' experience with an average of 11 years' experience across all the respondent unlike yam production where many of the farmers had average of 17 years' experience as reported by Ekunwe (2018) and Iroegbu *et al.* (2021). Only 38% belong to association, also 84.5% do not take potato production as primary occupation.

Most of the potato farmers financed their operations through personal saving (66.5%). On the other hand, 67.5% were full time farmers only 32.5% were part time farmers. About 81% of the respondents used vine cuttings instead of seeds/tubers as planting material. Nwinyi (1991) reported that best yield is obtained by use of vine cuttings. Greater number of respondent representing 63% obtained their planting material from the market. This could be attributed to poor extension service. Most of the potato farmers do not apply fertilizer, representing about 81% respondents, which means that the use of fertilizer is not popular in the area; majority of the respondents (46.5%) indicated that they made use of family members as source of labour with 36.5% relying on hired labour. This explains why they have large family sizes. About 53.5% of the respondents got their farm land through inheritance; this is primarily due to the prevalence of communal land tenure system and family land inheritance. Most of the farmers cultivated on farm land sizes of between 0.5 – 1.5 hectares with averages farm size of 1.0ha, this also could be attributed to the system of land fragmentation. Hence cost of land is very high and farmers could not afford it. Adenyonu *et al.* (2019) identified high cost of land as major constraint to sweet potato production.

The result on table 3.2 shows the co-efficient estimate of MLE from the sweetpotato farmers. The stochastic frontier production function assumes Cobb-Douglas production function. Therefore, the values of the co-efficient of the various variables can be used as the value of elasticity of the production function and so can represent proportional changes in sweetpotato production as a result of proportional change in the inputs used in sweetpotato production in the study area.

It can be seen that some inputs like land (area cultivated), fertilizer, and potato vine cuttings had positive co-efficient of 1.636, 0.692 and 0.336 respectively, significant at 1% levels. This implies that a one percent increase in this input will result in a corresponding increase in sweetpotato production by 1.636, 0.692 and 0.336 respectively. Thus there is a direct relationship between these inputs and yield (output) of sweetpotato in the study area. On the other hand, labour input showed no statistical significance. This is contrary to apriori expectation. It might also be explained by the law of diminishing returns, labour usage may have been saturated due to the fact that most rural farmers make use of family members as source of labour, therefore, there could be over employment/engagement of labour. This agrees with Shehu *et al.* (2011) who reported that rural farmers were over utilizing labour input in yam production. However, Oladele *et al.* (2014), Babatunde *et al.* (2015) reported a positive coefficient for planting materials and fertilizer inputs as a way of increasing output.

# 3.2 Technical Inefficiency

Looking at the inefficiency parameter, the result was capable of explaining the source of various inefficiencies experienced by the sweetpotato farmers in the study area. A negative coefficient value indicates that such variable is capable of reducing technical inefficiency of the farmers, while any

positive co-efficient value is capable of increasing technical inefficiency. The result from table 3.2 revealed that years of experience, level of education, size of house hold, age of the farmers, and gender had negative coefficient which implies that they help to reduce technical inefficiency and improve efficiency of the farmers, while source of land source of finance and marital status contributed to increasing inefficiency. This result agrees with Abdallahi (2015) who reported that technical inefficiency decreased with an increase in the level of education of yam farms. Also Jude (2011) reported that marital status reduces farmers' technical efficiency. The result corroborate the findings of Ekunwe *et al.* (2007) who reported that age of the farmer was significant in decreasing technical inefficiency. The more years of schooling the more knowledge gained which helps in enhancing the ability to acquire technical skills or knowledge as to apply improved techniques of production. The result reveal a positive coefficient for sigma squared ( $\delta^2$ ) significant at 1% level which gives credibility to the model and various assumptions, where as the gamma (y) estimated value is 1.000 which was significant at 1% level. This implies that about 100% of the variations in potato output among respondents were attributable to differences in their level of technical efficiencies.

# 3.3 Distribution of technical efficiency range for production estimate of sweetpotato farmers in Etche Local Government Area

The table 3.3 above showed that potato farmers had a minimum efficiency range of 0.553 while the maximum efficiency range was 0.995, the mean efficiency of the farmers was 0.755 which is about 76%. This means that an average farmer need at least 24% adjustment in resource to be 100% efficient in resource allocation. However, the least efficient farmer will need about 45% adjustment in resource allocation while the best efficient farmer needs 1% adjustment in resource allocation to be efficient.

Table 3.4 above shows marginal physical product (MPP) values for various inputs, relying on the productivity estimate gotten from the MLE table. The MPP farm area / land is 11.33, labour is 40.35 planting materials are 26.88, while fertilizer is 15.098. The marginal value product (MVP) for the inputs was 13.064, -32.280, and 21.504,12078 respectively. The table showed allocative efficiency index for land, labour, planting material (vines) and fertilizer as follows, 0.1451, -12912, 25.299, and 60,392 respectively. From this result, the MPP and APP for land is 11.33 and 9.979. This means that if land increases by 1 hectare (1ha) output of sweet potato will increase by 16.33 tons, on the other hand one hectare contributes an average of 9.976 tons to the overall output of potato. However,

APP<MPP this shows that farmers are at the stage 3 of production function. Also the table showed that MPP for

labour was (-40.35). This is a negative value, which means that labour input has no marginal effect to output hence it appears to be grossly over utilized. According to Coelli *et al.* (1996) an input resource is efficiently allocated when the allocative elasticity index (AEI =1) and (MVP =Px). Therefore, looking at the results on table 3.4 above, land has AEI (0.1451) (Labour is -12912) planting material (25.299) and fertilizer is (60.392), this indicate that planting materials and fertilizer were underutilized, while labour was over utilized. All indicating that there were various degrees of inefficient use of resources among the sweet potato farmers in the study area. This result agrees with the findings of Ekunwe *et al.* (2018) that rural farmers in the Tai local government area of Rivers State were inefficient in resource usage/allocation.

The costs and returns/profitability analysis on table 3.5 above shows gross revenue from one hectare of potato production at 1920,000 with a total variable cost (TVC) of 167,500 and fixed cost of 120,000. Also the table shows a gross margin (GM) 1752,500 and net from income (NFI) 1,632,500. Further analysis revealed that return on investment (RI) was 0.9127604 which gives a gross margin percentage of 91.27%. This result implies that any naira investment in sweet potato production in the study area will result or produce a profit of 91.27%. This result indicate an almost 100% return on investment, with this there is no doubt that sweetpotato farming is a profitable venture. This result agrees with the findings of Omoare (2017) Adenyonu (2018); potato production was profitable and should be encouraged.

Table 3.6 results from a five point Likert scale which revealed various degrees of impact of different factors affecting the operation of sweetpotato farmers in the study area. Generally any value of mean below (3.0) is regarded not to be a constraint against sweetpotato farmers in the study area. Therefore, close examination of the table showed that several factors constituted serious challenge against sweet potato production in Etche Local Government Area of Rivers State. High cost of planting materials (vines) transportation, lack of capital, poor access to bank loan, high cost of labour, destruction of crops by herders cattle and high cost of land ranked amongst the highest challenge extremely serious constraint (ESC). This is in line with the findings of Adenyonu *et al.* (2019) and Abdulahi (2015) who identified lack of capital, poor access to credit and high cost of planting materials as a major constraint to farmers. In the same vein, poor pricing of produce due to inadequate storage, lack of extension service were indicated as serious constraints to sweetpotato production. This result agrees with Gbegeh and Akubuilo (2013) who also opined that lack or inadequate extension service were major constraint to potato production.

# 4.0 Conclusion

The result showed a wide range of technical efficiency among sweet potato farmers in the study area. The mean technical efficiency implies that an average farmer needs some adjustment in resource allocation to attain full efficiency. However, gross margin analysis / profitability study showed a positive return on investment (RI), This means that sweet potato farming in Etche local government area is a profitable venture, even though the farmers were not efficient in the allocation of resource as the allocative elasticity index (A E I) indicate that (AEI±1) not equal to one, and the (MPV± Px). Certain constraints were identified such as lack of capital, high cost of planting materials, lack of access to bank loans, high cost of labour and the destruction of crops by herder's cattle among others. Recommendations were made that government should subsidize the cost of input, create more accessible funds to farmers, and farmer should also approach some (NGO) non-governmental organizations who are interested in agricultural development. Adequate security, arrangement and collaboration to stop destruction of crops by herders cattle. There should be more awareness to encourage youths to engage in farming as to boast food sufficiency in the country.
