Metal Pollution: Sources, Health Effects and Antioxidant Composition of Vegetables Cultivated in Urban Lagos, Nigeria

Abstract

High heavy metal pollution of the environment has been tied to civilization, urbanization, and industrialization, leading to the overwhelming of natural cleansing and cycling processes in many ecosystems. This study investigates the sources, the extent of pollution and possible health effects of heavy metals via edible vegetables grown in the urban areas of Lagos metropolis. Plants, soil and irrigation water samples were randomly collected in triplicates from vegetable farms in four most industrialized/commercialized Local Government Areas of Lagos State (Ojo, Amuwo-Odofin, Yaba and Kosofe). Dusts and particulate matter deposits on the abaxial leaf surfaces were analyzed for atmospheric deposition. Dried plants were crushed into fine powder before extraction. The physico-chemical, phytochemical and anti-oxidant composition of the plant parts were determined using standard methods. Atomic absorption spectrometer was used to determine heavy metal composition. Plant samples were authenticated as Allium Schoneoprasum (LUH 9803), Lactuva Sativa L. (LUH 9084) and Amaranthus spp. (LUH 9085). The highest concentration of chromium (7.6±0.00), cadmium (5.1±0.04) and zinc (9.7±0.01) were observed at Kosofe while that for copper (5.2±0.04) and lead (15.7±0.03) was found at Ojo and Amuwo-Odofin soil samples respectively. Estimation of the chronic daily intake (CDI), target hazard quotient (THQ), and health risk index (HRI) showed no carcinogenic threat to the food chain, with values under the permissible daily intake limit.

1.0 Introduction

Heavy metals (HMs) are group of metals/ metalloids whose specific gravities and atomic densities are greater than 5 and 4 g/ cm³ respectively (Barzegar *et al.*, 2015; Enuneku *et al.*, 2018). Heavy metals naturally occur and persist on the earth's crust. Lately, emission of HMs into the environment, as result of human activities have exceeded the tolerable limits of natural cleansing and cycling processes in many ecosystems. Typical hot spots of heavy metal contamination are urban areas with intensive industrial and mining activities. HMs gain entry into the human body through oral, nasal and skin channels (Ogundele *et al.*, 2019; Orosun *et al.*, 2023). HMs such as Cd, As, Pb, Mn, Fe, Cr, and Hg have long biological half-life, as such interfere with the normal performance of living tissues, resulting in various diseases (Suvarapu and Baek, 2017; Barzegar *et al.*, 2019; Kumar *et al.*, 2020; Prodipto, *et al.*, 2024). In the biological system, HMs metals target cellular processes through induction of oxidative stress, impaired membrane integrity, protein function destabilization, assimilation of nutrients and DNA damage. HMs have also been shown to induce antibiotic resistance through co-selection.

Plants and their products are probably the most important in human diet but may be contaminated with toxic metals like Hg, Cd, Pb, and As, (Esther and Coskun, 2025; Efretuei *et al.*, 2023); Karimi-Maleh *et al.*, 2021; Stefanovic *et al.*, 2008; Dodangeh *et al.*, 2018). Plants and plant products contamination with HMs has been majorly attributed to anthropogenic activities such as discharge of industrial effluents, mining, improper disposal of waste, sewage irrigation of agricultural crops, application of fertilizers (e.g. phosphate) etc. (Shariatifar et al., 2022; Fathabad *et al.*, 2018). Soil, and water contaminations are primarily suggested to be from atmospheric deposition of HMs, resulting in food chain contaminations (Fakhri *et al.*, 2018; Qu *et al.*, 2012).

Amaranthus sp (L) is a tropical annual crop belonging to the family Aaranthaceae with about 70 species (Aguilar et al., 2011). Majority are endemic to North America, with only a few species from Asia, Africa, Australia, and Europe (Iamonico, 2023). Amaranthus is rich in proteins (13–22%), lipids (5–13%), dietary fiber (9–14%), vitamins (ascorbic acid, riboflavin, niacin), minerals, among others (Alegbejo, 2014). Amaranthus protein is unique in its lysine and methionine composition which serve as natural source of squalene replacement (polyunsaturated triterpene compound) (Park et al., 2020). It's a drought-resistant crop with untapped commercial and industrial potential (Akin-Idowu et al., 2017).

Lactuca sativa (L.), a member of the Asteraceae family is one of the most widely consumed leafy vegetables on the planet (Lawal et al., 2017). While Asteraceae are thought to be the largest family of plants with over 30,000 species (Bessada et al., 2015):Panero and Crozier, 2016), Lactuca sativa has been shown to be high in vitamins K, E, and C as well as carotenoids (Shi et al., 2022). It is traditionally used in the management of inflammation, pain, stomach ache, indigestion, and lack of appetite (Noumedem et al., 2017).

Allium schoenoprasum (L) (common names: Spring onion, scallion, Welsh onion, salad onion, etc), is a non-bulbing, bunch-forming green onion belonging to the Liliaceae family(Alam *et al.*, 2023). This plant is mostly grown in northern Nigeria as well as temperate and tropical parts of the world. The leaves are eaten raw as vegetables in soups, rice, salads, etc. (Dery & Zaixiang, 2020).

Toxic metals have been shown to bio-accumulate in organs and tissues of man including the kidney, liver, bone, and brain (Liu *et al.*, 2020; Bjørklund *et al.*, 2017) and have been implicated (especially Hg and Pb) in children and infant developmental disorders such as lowering

intelligence quotient (Heng et al., 2022; Raj & Maiti, 2020). Lead (Pb) and cadmium (Cd) have been implicated in cancer (Parida & Patel, 2023).

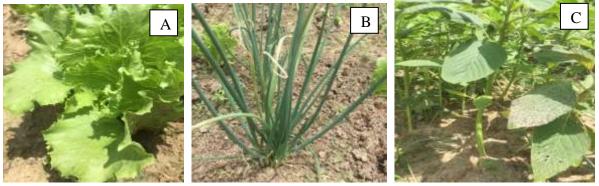


Figure 1.1 (A) Lactuca sativa (B) Allium schoenoprasum (C) Amaranthus spp.

Farming in Nigeria has become a high-risk and low paying job due to increased insecurity caused by banditry, militancy, kidnapping, farmers and herders conflicts, rural-urban migration among others. Most rural farmers can no more go to the farm for fear of being kidnapped or even killed by bandits. Unable to make a living in the rural areas, majority are forced to migrate to the cities. The few available spaces in the city centers have been turned to horticultural gardens and farms with its attendant health risk from metal pollution, owing to human activities. Agrawal et al., (2003) suggests that air pollution of agricultural land around industrial centers and highways account for increased levels of toxic metal uptake by plants in the area (Manisalidis et al., 2020). However, urban agriculture in developing countries play a significant role in managing hunger and improving food security. Irrigation water quality and the accumulation of heavy metals in fresh farm produce presents a research area yet to be thoroughly studied. Little or no attention has been paid to this brewing health emergency. In this study, several metal and environmental indices were used to measure associated health risks of HMs ingestion of the populace, through the consumption of vegetables. This allows for a better understanding of the biological effects of HMs in humans. Children, as a result of their physiological and behavioral patterns, have been reported to be the most responsive age group (Al Osman et al., 2019; Zheng et al., 2023). Urban agriculture has become an increasingly important component of food security in many developing and developed regions. However, the risk of contamination by heavy metals due to proximity to industrial zones, traffic emissions, and the use of untreated wastewater poses significant concerns for public health. This study aims to investigate the extent and impact of metal pollution in vegetables cultivated in urban environments

2.0 Materials and Methods

2.1 Study Area

This study was conducted in Lagos State, Nigeria. Known as the 'commercial nerve center of Nigeria', Lagos State is characterized by the heaviest traffic on major highways along where the horticultural farms are located. With average temperature of 24°C, average humidity level of 69, the state has two distinct dry and rainy seasons, which runs between the months of November to March and April to October respectively.

2.2 Sample Collection and Preparation

Plants, soil and irrigation water samples were randomly collected between the months of May and July, in triplicates from vegetable farms in Ojo (6.47586°N, 3.2018°E), Amuwo-Odofin (6.46143°N, 3.312627°E) Yaba (6.5016°N, 3.3685°E) and Kosofe (6.59878°N, 3.409463°E) Local Government Areas in Lagos state, Nigeria. Dusts and particulate matter deposits on the

abaxial leaf surfaces were analyzed for atmospheric deposition. The plant samples were authenticated at the University of Lagos Herbarium as *Allium schoneoprasum* (LUH 9803), *Lactuva sativa L.* (LUH 9084) and *Amaranthus spp.* (LUH 9085). The dried plant sample were ground into a fine powder before extraction.

2.3 Physico-chemical and Phytochemical Composition

The methods of Ejikeme *et al.*, 2014 and Chekroun *et al.*, 2014 were used to determine phytophysicochemical composition of the soil and irrigation water samples.

2.3.1.Anti-oxidant Composition

The Assay of Superoxide Dismutase (SOD) was done by monitoring the superoxide radical-induced nitro blue tetrazolium (NBT) reduction at 560nm, according to the method of Cakmak and Marschner, (1992).

DPPH Assay

This assay was performed only with slight modification to the description of Estrada *et al.*, (2016). The DPPH was prepared by mixing 0.004 g of DPPH in 100 ml methanol. Using methanol as the blank, the control contained only DPPH solution in place of the sample. 2.0 ml of DPPH reagent solution was mixed with an aliquot of 0.5 ml ethanol and aqueous extract. The mixture was vigorously shaken and left to stand at room temperature. An initial spectrophotometric reading of each extract in MeOH was performed. After 30 minutes, quenching of DPPH free radicals, were read at 517 nm from the decrease in absorbance of the test mixture. The results were obtained using the following formula:

2.3.2 Determination of FRAP Potentials in Samples

This assay is based on the principle of reduction of ferric-tripyridyltriazine (Fe³⁺-TPTZ) complex to ferrous tripyridyltriazine (Fe²⁺-TPTZ) by the antioxidants of a sample at low pH. FRAP reagent was prepared by mixing 300 mM acetate buffer, pH 3.6 in 40 mM HCl, and 20 mM FeCl₃ at 10:1:1 v/v/v. 3.400 μ L of the reagent and 100 μ L of the sample solutions were added to each well and mixed thoroughly. After 30 minutes, the absorbance was measured at 593 nm. A standard curve was prepared using different concentrations of trolox. All solutions were used on the day of preparation. The results were expressed as μ mol trolox equivalent/g dw.

2.3.3 ABTS Radical Scavenging Assay

The free radical scavenging activity of the plant extracts was determined using 2,2'azinobis-(3-ethylbenzthiazoline-6-sulphonic acid) (ABTS), radical cation decolorization assay and 6-hydroxy 2,5,7,8-tetramethylchromane-2-carboxylic acid (Trolox) as a standard. ABTS was dissolved in water to a 7 mM concentration. ABTS radical cation (ABTS*+) was produced by reacting ABTS stock solution with 2.45 mM potassium persulphate (final concentration) and allowing the mixture to stand in the dark at room temperature for 12 to 16 hours before use. The free radical was stable in this form for more than two days when stored in the dark at room temperature. For this study, ABTS*+ solution was diluted with ethanol to an absorbance of 0.70 (± 0.02) at 734 nm. Reagent blank reading was also taken (A0). After the addition of 1.0 ml of diluted ABTS*+ solution to 100 μ L of each plant extract, the absorbance reading (Ae) was taken exactly 2.5 minutes after initial mixing. The plant extracts were first adequately diluted (where necessary) to fit within the linearity range. The percentage inhibition of absorbance at 734 nm was calculated using the formula

The antioxidant capacity based on the ABTS free radical scavenging ability of the extract was expressed as mmol Trolox equivalence antioxidant capacity (TEAC) per 100 g of plant material.

2.4 Heavy Metals Assay using Atomic Absorption Spectrophotometer

The extracts and the blanks were analyzed in the Federal Institute of Industrial Research (FIIR) CFET Laboratory, Oshodi, Lagos State using atomic absorption spectrophotometer (UNICAM 10230).

2.4.1Bio Concentration Factor

The ratio of metal concentration in the edible parts of the studied vegetables and the soil was used to calculate the bio-concentration factor (BCF). BCF value less than 1 (< 1), indicates low metal accumulation in the plant, from the soil while BCF value greater than 1 (> 1), indicates high metal accumulation. The BCF were estimated using equation 1 (Ani et al., 2020).

2.4.1 Factor Assessments

2.4.1.1 Chronic Daily Intake

The chronic daily intake of the studied metals were calculated using the formula below (EPA 2015).

2.4.1.2 Non-carcinogenic Health Risk

The non-carcinogenic risk of the heavy metal content of the sample vegetables was calculated using the equation 3.

Where Edi= Estimated daily intake of the heavy metal.

C = Concentration of heavy metal in (mg/kg/dw)

EF = Exposure frequency (365 days per year)

BW = Adult body weight average (70kg)

AT = Average time of exposure for non-carcinogenic health risk (25,550days)

ED =Exposure duration (70 years).

2.4.1.3 Target Hazard Quotient (THQ)

This estimates the carcinogenic risk of heavy metals in the plant samples. Plant samples with heavy THQ value less than 1 (< 1) pose no carcinogenic risk to the exposed populace, while plant samples with THQ value greater than 1 (> 1) suggests a carcinogenic health hazard

potential. Health risk hazard is enhanced with increased THQ. The THQ assessment was estimated using equation 4 below.

2.4.1.4 Health Risk Index (HRI)

The health risk index (HRI) is the estimation of health risk involving more than one heavy metal. The HRI is the sum of the individual heavy metal target hazard quotient. The HRI value less than 1 << 1) is of no carcinogenic risk, while HRI value greater than 1 <> 1), poses a carcinogenic hazard risk. The HRI was estimated using equation 5.

2.5 Statistical Analysis

Data obtained was analyzed using Statistical Package for Social Sciences (SPSS, Version 20.0). Using a one-way analysis of variance (ANOVA), all data are reported as mean SD of two replicates of each sample, considering (p < 0.05).

3.0 Results and Discussion

3.1 Physicochemical, Phytochemical and Antioxidant Composition

The analysed soil samples showed marked variation in physicochemical parameters as presented in Table 3.1. The lowest pH was observed in Ojo (5.74), while Kosofe had the highest (6.27). Organic carbon was observed to be highest in Yaba (14.1%), and lowest in Ojo (2.67%). Salinity measure showed an increasing value of 3.11< 3.45< 3.48<4.17 for (Ojo, Amuwo-Odofin, Yaba and Kosofe) respectively. The electrode potential of the soil samples were 27.63, 54.51, 60.91 and, 88.22 for Amuwo-Odfin, Ojo, Kosofe and Yaba respectively. Other results such as phosphate, exchangeable ions are presented in Table 3.1. Results for physico-chemical properties of irrigation water sample are presents in Table 3.2. Results indicate general acidicity (4.78^A±0.11-5.84^C±0.00). Results for the four locations (Amuwo-Odfin, Ojo, Kosofe and Yaba) show dissolved oxygen (Mg/L) 8.23^B±0.04, 7.08^A±0.03, 7.86^B±0.08, 8.27^B±0.33, Salinity (ppm) 3.21^D±0.12, 2.84^{CD}±0.21, 2.63^{CD}±0.16, 2.43^C±0.08 and Chemical Oxygen Demand (COD) 5.06^A±0.54, 2.19^B±0.04. 2.73^B±0.09, 2.25^B±0.06 respectively (Table 3.2).

Several authors had established a positive correlation between physicochemical properties and metal composition of soil (Ibiene *et al.*, 2011) (Murthuza *et al.*, 2022) (Islamd *et al.*, 2023) (Louhar *et al.*, 2020). In addition, soil biology is negatively affected by excess of heavy metals and synthetic chemicals, altering the physicochemical characteristics of the soil and causing other environmental problems (Qu *et al.*, 2019) (Alengebawy *et al.*, 2021) (Hatami-manesh *et al.*, 2021). Table 3.3 ,presents the phytochemical composition of *Allium schoenoprasum*, *Lactuca sativa* and *Amaranthus spp. Allium schoenoprasum*, had highest value for flavonoid (0.61^F±0.08), *Amaranthus spp* had the highest value for alkaloids (0.35^E±0.02), saponins (0.13^I±0.00) and phenol (6.66^M±0.01), while *Lactuca sativa* had the highest value for oxalate (0.11^J±0.00). The antioxidant composition of the vegetables are presented in Table 3.4. Superoxide Dismutase (SOD) is shown to increase with increasing concentration in all the

vegetables. Highest amount of hydrogen peroxide is found in *Lactuca sativa* ($1.21^{Q}\pm0.00$), *Allium schoenoprasum* had the highest amount of DPPH ($0.70^{R}\pm0.00$), while *Amaranthus spp.* had the highest amount of FRAP ($3.11^{V}\pm0.00$). Generally, low antioxidant activity was observed in the three vegetables sampled, although (Karamać et al., 2019) showed high antioxidant activity in *Amaranthus caudatus*

3.2 Heavy Metal Concentration of Soil and Irrigation Water

The heavy metal concentration of the analysed farm soil sample for the four locations (Amuwo-Odofin, Ojo, Kosofe and Yaba) show that Chromium (Cr) 6.1 ± 0.04 , 4.9 ± 0.00 , 7.6 ± 0.00 , 3.2 ± 0.02 , Cadmium (Cd) 4.3 ± 0.01 , 0.00, 5.1 ± 0.04 , 0.3 ± 0.01 , Zinc (Zn) 7.3 ± 0.02 , 4.4 ± 0.01 , 9.7 ± 0.01 , 8.1 ± 0.00 , Copper (Cu) 2.9 ± 0.01 , 5.2 ± 0.04 , 1.8 ± 0.00 , 2.3 ± 0.01 and Lead (Pb) 15.7 ± 0.03 , 10.1 ± 0.01 , 7.2 ± 0.01 , 6.8 ± 0.08 respectively. Kosofe had the highest value for chromium (7.6 ± 0.00), cadmium (5.1 ± 0.04) and zinc (9.7 ± 0.01). The highest value for copper (5.2 ± 0.04) was found at Ojo while the highest value of lead (15.7 ± 0.03) was observed at Amuwo-Odofin. Results, show that cadmium concentrations in Amuwo-odofin (4.3) and Ojo (5.1), are higher than the World Health Organization (WHO) standards for metals in soil samples (WHO, 1996, 1998).

Results for heavy metal concentration of the analysed irrigation water sample for the four locations (Amuwo-Odofin, Ojo, Kosofe and Yaab) show the values for chromium (Cr^{+6}) 0.01±0.00, 0.04±0.04, 0.30±0.01, 0.26±0.07, zinc (Zn) 0.82±0.02, 1.24±0.01, 0.48±0.09,

1.49±1.63 copper (Cu⁺²) 0.24±0.01, 0.21±0.00, 0.21±0.00, 0.33±0.01 and lead (Pb⁺²) 2.02±0.02, 1.88±0.08, 0.50±0.03, 4.80±0.12 respectively. Cadmium and arsenic were not detected in the water sample. Irrigation water is water used to wet agricultural land for crop production and this can be a major source of heavy metal accumulation in edible plant parts (Sha *et al.*, 2023). Table 3.2 summarizes the physico-chemical properties of irrigation water sample. The result showed an acidic pH level of between 4.7 and 5.8. This, is below the WHO and FAO pH range of 6.5–8.5 and 6.4–8.4, for irrigation water respectively. Electrical conductivity was between 659 -1064 μS cm⁻¹. This is far above WHO recommended value of 400–600 μS cm⁻¹. Electrical conductivity is a measure of dissolved salt in water (Orosun *et al.*, 2023). High amount of dissolved salt may have accounted for the acidity of the irrigation water. Vegetables irrigated with contaminated water may cause serious health hazards to the community(Berhanu *et al.*, 2022; Drechsel *et al.*,2017; Hussain *et al.*, 2017) Industrial and consumer wastes, open defecation and the presence of uncontrolled landfills, are heavy metal contamination sources of water supply (Obasi *et al.*, 2024; Berihun *et al.*, 2023)

3.4 Metal Concentration in Plant Parts and Biological Concentration Factor (BCF)

Results for metal concentrations in the plants are summarized in Tables 3.5. The analysed plant parts showed a wide range of variation in heavy metal concentration. Metal concentration in Kosofe samples were in the form Cr>Zn>Pb>Cd>Cu>As for roots and Zn>Cr>Pb>Cd>Cu>As for shoots. Of all locations, the highest concentration of Cr was at Kosofe which were all higher than the WHO recommended standard and lowest at Yaba. Zinc (ZN) and Arsenic (As) had the highest concentration in samples for Amuwo-odofin and Ojo respectively (Table 3.5). The presence of Arsenic and Cadmium in the plant samples in quantities higher than WHO recommendation is a call for serious health emergency bearing in mind the consequences of these metals in even trace amounts. Assessment metal pollution sources through atmospheric depositions showed Pb>Cu>Cr>Zn for all locations. Highest concentration of Pb (4.06) were from Amuwo-odofin while Kosofe had the highest value for Cu(0.66), Cr(0.40) and Zn(0.07). Arsenic and Cadmium were not detected in the atmospheric samples for all locations.

The biological concentration factor (BCF), show that most of the metals were easily absorbed from the soil and readily transferred to the aerial plant parts (Table 3.6). Movement of the metals has been shown to be influenced by soil physico-chemical characteristics. This agrees with this research findings by Tang *et al.*, (2020); Mfon *et al.*, (2022 and Ani *et al.*, (2020. The documented adverse effect of heavy metals on plants and human health, shows mercury, lead, arsenic, and cadmium are toxic metals and have mutagenic effects even at very low concentrations (Jaishankar *et al.*, 2014; Mitra *et al.*, 2022; Hembrom *et al.*, 2020). Human consumption of heavy metal contaminated vegetables may cause immunological disorders, impair psycho-social behavior, and growth retardation. There is an urgent need of increased awareness on the side-effects of heavy metals on human health. Figure 3.1 presents the component loading scatter plot.

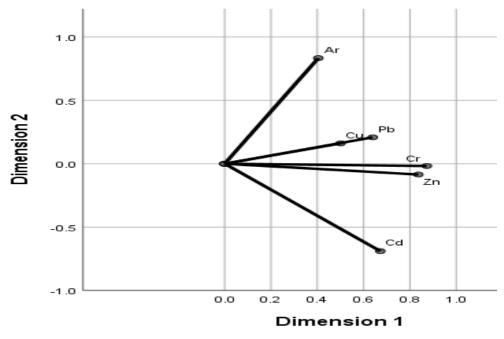

3.5 Factor Assessments

In this study, the heavy metals chronic or estimated daily intake (CDI)/(EDI) were all found below provisional permissible limits of daily intake or oral reference dose limit of USEPA 2021 (Table 3.7). The target hazard quotient of the heavy metal concentration of the vegetables was estimated to determine the carcinogenic exposure risk of adults and children consuming vegetables in sample soils. This research found the THQ of the metals in the vegetables to be of no carcinogenic threat. This is evident as all THQ values were far below 1 (>1) (Table 3.8). The health risk index (HRI) also showed no immediate carcinogenic threat to the food chain.

4.0 Conclusion

This study showed most of the metals assessed are within the USEPA 2020 permissible limit for heavy metals in farm soil except cadmium (Cd) whose concentration was high in two locations (Amuwo-Odofin and Ojo). The irrigation water were however acidic resulting from high dissolved salt. Results for estimated daily intake (EDI), the Target hazard quotient (THQ) and the health risk index (HRI) were found to be of no immediate carcinogenic threat, within the provisional limits of USEPA 2021. Regular monitoring of agricultural farms within the city is strongly recommended in other to regulate (where necessary) anthropogenic contamination with toxic metals.
